**Student Government Association Resolution 12 (AY 12-13)**

*Supporting the Addition of a Paid Student Worker Position to the Bylaws*

WHEREAS, The Student Government Association has a duty to communicate to UIS students, and provide timely information of current business and initiatives,

WHEREAS, The current Student Government Association website and social media has fluctuated in quality through the years, and our outreach depends on maintaining the student government website as well as all social media content,

WHEREAS, In order to maintain the Student Government Association website as well as up to date social media content, the Student Government Association should create a designated position to fulfill these duties and improve our communication to the student body,

WHEREAS, the current Student Government Association has already approved the creation of Web and Social Media Manager for the current academic year,

WHEREAS, the position of Web and Social Media Manager is not included in the current bylaws,

WHEREAS, an addition of the position of Web and Social Media Manager to the Student Government bylaws would ensure the continuity of this position,

THEREFORE IT BE RESOLVED, That the Student Government Association amend the current bylaws under Article II, Section 1 with the addition of a Clause J,

**Clause J. The president, in consultation with the Student Government Association advisor, shall hire a Staff Position for a Web and Social Media Manager for the Student Government Association. This position will be hired through the Office of Student Life. At the first meeting of each academic year, the President shall request the funds necessary for the hiring of this position from the Student Government Association.**

**Sub-clause 1. If the Web and Social Media Manager is not meeting the necessary requirements the President, with 2/3 majority vote approval from the executive board and in consultation with the Student Government Advisor, shall reserve the right to terminate the current worker and seek a replacement for the position.**

THEREFORE BE IT FINALLY RESOLVED, that The Student Government Association amends the current bylaws under Article II, with the addition of a Section 9,

**Section 9. Web and Social Media Manager**

**Clause A. The Web and Social Media Manager shall provide website maintenance and social media services to the Student Government Association.**

**Clause B. This Web and Social Media Manager shall attend the necessary training in order to become a publisher for the Student Government Association Website.**

**Sub-clause 1. The Web and Social Media Manager shall maintain the SGA website through weekly updates of SGA announcements, minutes, agendas, resolutions, initiatives, and other relevant content.**

**Clause C. The Web and Social Media Manager shall maintain social media sites including Facebook, Twitter, among others for the Student Government Association as well as the Student Organization Funding Association.**

**Clause D. The Web and Social Media Manager shall meet regularly with the Chairs of Student Organization Funding Association (SOFA) and the Student Activities Committee (SAC).**

**Sub-clause 1. The Web and Social Media Manager shall maintain the SOFA and SAC webpages and their corresponding forms bylaws, meeting information, and other relevant information.**

**Clause E. The Web and Social Media Manager shall report jointly to the Student Government President or designee, as well as the Student Government Adviser.**
