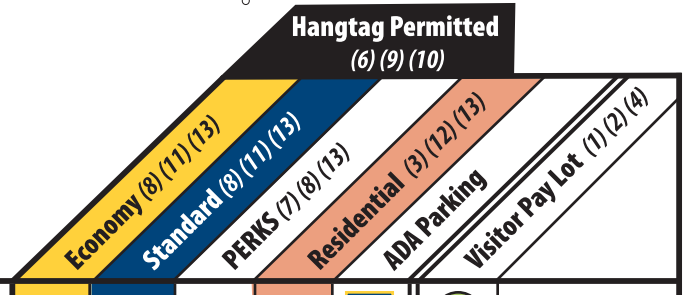

GENERAL

No person shall park a vehicle in a location other than an authorized parking lot or space, in a reserved parking space without appropriate permit, where prohibited by a sign or a yellow curb marking, in a marked loading zone for a period longer than the allotted posted time, on walks or grass, in a driveway unless marked or posted, so as to block a crosswalk or driveway, so as to block cars legally parked, so as to block a wheelchair ramp, in a designated parking space for emergency vehicles or other authorized vehicles, on a campus street or driveway except where posted, in a handicapped space unless the vehicle meets the

standards for handicap parking as defined in Chapter 625, Illinois Compiled Statutes, and/or in a fire lane with the exception of emergency vehicles. The University assumes no liability for vehicles parked or operated on university property. For a complete set of Parking Rules and Regulations, please visit uis.edu/parking. VISITORS

- (1) Visitors are invited to park in one of the following lots with parking pay stations: B-West, C-North, D, G, I-South, J; or in spaces with individual meters. Payment is required 24/7 in pay station lots and in metered spaces. Overnight visitor parking is in Lot B-East in the individually metered spaces.
- (2) Visitors attending the Performing Arts Center (PAC) shall park in lots C-North, C-South, D, and E, as directed by PAC staff or in accordance with (1) above.

- (3) Visitors shall not park in residential parking lots.
- (4) Visitors attending a conference shall park in lot(s) designated for the conference or in accordance with (1) above.
- (5) Visitors attending special events are advised to confirm event parking location(s) with the event coordinator.

UNIVERSITY STUDENTS AND EMPLOYEES

- (6) The purchase and issuance of a parking hangtag does not guarantee convenient parking on university property (with the exception of PERKS) nor does it guarantee parking will be available in an individual's preferred parking location.
- (7) Individuals with a PERKS hangtag may park in their PERKS 24/7/365 and in any Standard or Economy Lot. Individuals with a Standard hangtag may park in any Standard or Economy Lot.
- (8) All full-time, part-time, and temporary faculty, students, staff, and employees of the University of Illinois Springfield must obtain and display a

- not have a PERKS in Lot J shall pay the parking pay station to park in Lot J.
- (10) Individuals with a Low Emissions Vehicle (LEV) shall only park in LEV spaces in the lots for which they have purchased a hangtag or paid the parking pay station to park.
- (11) Lot hours may be restricted and/or extended to accommodate university events. The number of available parking spaces in a lot may be restricted to accommodate university events.
- (12) Residential parking hangtags authorize students to park in specific residential parking lots.

- Residential parking hangtags are not valid in Economy or Standard lots or in PERKS.
- (13) If parking a borrowed or rented vehicle on campus, a valid and current parking hangtag must be displayed or individuals may park in spaces with a meter or in one of the following lots with parking pay stations: B-West, C-North, D, G, I-South and J.
- (14) Students, faculty, and staff with any valid hangtag may park overnight in Lot B-East or I-North when traveling on official university business.
