- Original documentation showing you have been designated as a Refugee, Person Granted Asylum, Parolee, Cuban-Haitian Entrant, or Conditional Entrant (I-94, I-94A, or I-571 with proper endorsements)

Victim of Human Trafficking or Battered Immigrant-Qualified Alien

- I-94 with a T1, T2, T3, or T COA code AND a copy of your eligibility letter from Health and Human Service (HHS) or a T-visa
- A copy of your 1-797, Approval Notice from USCIS, with a valid expiration date verifying financial aid eligibility
