Summary of FY 09 Activity

Despite the financial struggles in the economy, the amount of Grants and Contracts received by UIS in FY 2009 increased by just over \$1 million in comparison to FY 2008. Between July 1, 2008 and June 30, 2009, UIS submitted 80 applications for funding, requesting a total of \$10.4 million. The campus received awards for 57 of those projects, for total funding of \$8.3 million.

Support from the state of Illinois remained UIS' top source of outside funding at 89.6%. Other funding sources included the federal government (3.1%), local government (.4%), commercial entities (.3%), and not-for-profit organizations (6.6%).

Individual awards, as well as a summary of award activity by unit, are listed in a later section of this Bulletin.

Review of Services Provided by the Grants and Contracts Office

The Preaward Grants and Contracts Office at the University of Illinois at Springfield resides in the Office of the Provost and Vice Chancellor for Academic Affairs. The office provides a variety of services for faculty, staff, and students, including:

- Identification of external funding sources
- Interpretation of sponsor guidelines and requirements
- Assistance with <u>all stages</u> of proposal development, including budget preparation
- Maintenance of a homepage, complete with links to relevant information and downloadable forms
- Classroom presentations on topics such as proposal writing and human subjects in research
- Assistance in finalizing protocols before submission to the Institutional Review Board for Protection of Human Subjects

Deb Koua, the Preaward Grants and Contracts Coordinator, is available for individual consultation or group presentations.

Human Subjects in Research

We would like to remind the campus community that any research project involving collection of data from human participants, which is conducted by UIS faculty, staff, or students, must be submitted to the Human Subjects Review Officer for review and approval before data collection can begin. Such projects include

course-related assignments that involve students interviewing or surveying others, the analysis of pre-existing data not accessible to the general public, as well as needs assessments and opinion surveys conducted as part of program planning and evaluation efforts.

Outstanding Master's Thesis/Project Award

Every fall, each UIS graduate program is invited to nominate one thesis or project for the UIS Outstanding Master's Thesis/Project Award. This year's submission deadline is **Friday**, **September 25**.

Nominations are reviewed by the UIS Research Board, and one thesis or project is chosen to be forwarded to the Midwest Association of Graduate Schools' annual Outstanding Master's Thesis competition. Fringe Benefit and Indirect Cost Rates

The FY10 fringe benefit rate for faculty and staff salaries is 39.58%. Student salaries and wages should be charged .59% for workmen's compensation only.

The campus' federally negotiated indirect cost rates changed effective July 1, 2009. Those rates are now 44.1% for on-campus projects and 18.2% for off-campus projects. The rates are calculated from the Modified Total Direct Costs of a project budget.

The typical indirect cost rate applied to proposals to state agencies and not-for-profit organizations is 10%. However, some of these organizations have restrictions on the rates that are allowed. Proposal budgets are expected to include the maximum indirect cost rate allowed by the sponsor. Any budget that does not include the full recovery allowed must be accompanied by a written request to waive indirect cost recovery. Only the Provost can approve the waiver of indirect cost recovery.

Library Grants "Go Green"

Often in the grant world, people focus on and pursue large awards to fund major projects. But as two of our UIS librarians can attest, often times a relatively small award can have a large impact on the campus community.

Pamela Salela, Associate Professor, Library Instructional Services and Christine Ross, Assistant Professor and Director of Collection Services, both received \$2,000 grants during fiscal year 2009 from the Consortium of Academic and Research Libraries in Illinois (or CARLI). CARLI offers grants annually to libraries across Illinois; the theme for the 2008 proposals was "Greening the Arts and Humanities."

Pamela's proposal was titled "Green and Sustainable: Education in the 21st Century." She was able to site the inclusion of environmental sustainability in the campus' strategic plan in making a case to start a collection of children's environmental literature directed toward a K-12 audience. The materials include a variety of literature, curriculum materials, and textbooks. Since receiving the materials, Pamela has been working on building connections with the Teacher Education Program and with individuals involved in developing Southwind Park in Springfield.

The award managed by Christine Ross focused on "Greening the Studio Arts." She was able to purchase over 40 books dealing with environmental friendly methods employed in the fine arts, including how to use recycled objects in art and how to minimize the environmental impact of art studios. Christine also cited the UIS strategic plan in her proposal, stating "This was definitely a timely offering for UIS."

Both librarians state that, in the current budget climate, these books would not have been purchased without the CARLI grants. And while books can be expensive, \$2,000 can make a big impact on starting a topical collection. In addition, items purchased with CARLI awards must be freely available to CARLI members, meaning that UIS has access to any of the environmental collections purchased around the state.

Congratulations to Brookens Library and these two outstanding librarians for taking advantage of a unique opportunity to build the library's collections!

NEH Summer Stipends

The National Endowment for the Humanities has set a deadline of October 1, 2009 for the Summer Stipends competition. The UIS campus may submit no more than two applications for this program: one from a tenured faculty member and one from a non-tenured faculty member. If you are interested in applying, please contact Deb Koua no later than **September 1.** If needed, the Research Board will review faculty proposals and determine which to nominate.
