### NOTICE OF INTENT TO CLARIFY A BARGAINING UNIT BY STIPULATION

Case No. 2024-UC-0022-C

Board of Trustees University of Illinois ("University") and American Federation of State, County and Municipal Employees, Council 31, AFL-CIO ("Union") have filed a petition to clarify the bargaining unit to add the titles of "Athletic Turf Specialist" and "Maintenance Repair Foreman" in the historical bargaining unit at the University. The proposed bargaining unit description is:

Included: Assistant Grounds Gardener, Assistant Tree Surgeon, Grounds Equipment Mechanic, Grounds Worker, Maintenance Equipment Operator, Maintenance/Repair Worker, Athletic Turf Specialist and Maintenance Repair Foreman.

Excluded: All supervisory, managerial, confidential and short-term employees as defined by the Illinois Educational Labor Relations Act and all other employees.

This Notice will be posted for a period of twenty (20) school days as defined in the Board's Rules and Regulations. Within this notice period, any party may petition the Illinois Educational Labor Relations Board to state objections to the proposed clarification.

The Illinois Educational Labor Relations Board is an agency of the State of Illinois and does not endorse any particular choice in connection with representation for purposes of collective bargaining.
