PURPOSE AND SCOPE page 3

The Sangamon County Citizen Survey is a collaborative effort between the UIS Center for State Policy & Leadership, the Community Foundation for the Land of Lincoln, and the United Way of Central Illinois. The project's purpose is to establish benchmarks and evaluate changes in residents' assessments of the quality of life in Sangamon County. The periodic survey will provide local leaders, community organizations, and citizens with longitudinal insight into issues facing local residents.

The 2013 survey was conducted by interviewers at the Survey Research Office, a unit within the Center for State Policy & Leadership at the University of Illinois Springfield. The survey is representative of Sangamon County, Illinois and the data was weighted for probability sampling and to match 2012 population estimates as provided by the U.S. Census Bureau.<sup>1</sup>

The sample for this year's survey includes 524 completed interviews (618 partial interviews). The landline component included 391 responses with a 12.1% response rate and 22.8% cooperation rate. The cell phone component included 133 responses with a 10.3% response rate and 19.6% cooperation rate.<sup>2</sup> The margin of error for the survey is plus or minus 4.2%. The survey was conducted from March 7<sup>th</sup> to April 9<sup>th</sup> 2013.

Many dedicated local leaders and organizations worked together in order to ensure the success of the 2013 Sangamon County Citizen Survey. In particular, the project is the direct result of the hard work of John Stremsterfer, President and CEO of the Community Foundation for the Land of Lincoln; John Kelker, President of the United Way of Central Illinois; Bob Gray, President of the Citizens Club of Springfield; and Dr. David Racine, Executive Director of the Center for State Policy & Leadership at UIS.

<sup>&</sup>lt;sup>1</sup> Weighting survey responses are done in order to ensure that the sample is representative of the population. Two separate weights were assigned in this project-probability and post-stratification. Probability weights are assigned based on an individual's chance to be included in the survey and post-stratification weights are assigned due to the fact that people with certain characteristics are not as likely to respond to the survey as others. Education, gender, age, and race/ethnicity were used as post-stratification weighting variables.

EXECUTIVE SUMMARY page 4

The following sections contain an expansive analysis of the data collected by researchers from more than 600 individual responses on 100 questions across nine different areas, including: culture and recreation, social well-being, health, education, economy, infrastructure, government and civic participation, environment, and public safety. Because of the depth of this survey, we believe we have accumulated enough data to discern some positive and negative areas in which the majority of residents are in agreement.

Sangamon County is rated highly as a place to raise children There are several factors that inform this but none as telling as the majority of residents (67.8%) that rated Sangamon County as either an excellent or good place to raise children. In addition, individuals who have children enrolled in local schools rated their schools positively. In fact, 82% of parents think that the quality of education their child receives at a local school is either excellent or good. While there are small differences between school districts as well as private v. public schools; overall, parents believe that their child is safe in local schools. And finally, the majority of respondents are satisfied with the recreational opportunities for youth in the area with 57.8% of respondents reporting overall satisfaction.

# Education programs are a priority for the area

In addition to asking respondents about K-12 education in the region, individuals were also asked about pre-Kindergarten programs, post-high school educational programs, and workforce development training programs. Across the board, respondents report that the educational-based programs are important and a priority for Sangamon County. When asked about their support for different forms of tax increases to assist various projects (infrastructure, education, alternative forms of transportation), support for local schools received the highest level of backing.

In fact, 20% of respondents report that they would support an increase in property taxes and 37.8% report that they would support an increase in local sales taxes to support local public schools. Overall, a majority of respondents (57.8%) support a tax increase to assist local public schools. Beyond K-12 education, citizens believe that both pre-Kindergarten programs and posthigh school institutions are important for the local community. 75.4% of residents believe pre-K programs are very important and 83.8% believe post-high school institutions are very important. An additional 14% believe that both pre-K programs and post-high school institutions are somewhat important. And finally, when asked whether increasing workforce/employment training programs and increasing the number of local apprentice training programs were a priority in the area, the majority of respondents report that both are a high priority. We find that 59.6% of respondents say that increasing workforce training programs are a high priority and 58.7% believe that increasing the number of local apprentice training programs is a high priority.

# Despite downward trends, crime is still a concern among Sangamon County residents

Regional data indicates that the number of violent crimes in Sangamon County have been a continued downhill trend for the past several years. In 2010, there were reported 1,452 violent crimes in Springfield and 170 in unincorporated Sangamon County. In 2011, there were 1,258 violent crimes in Springfield (no data available on the unincorporated area). Most recently in 2012, there were 1,138 violent crimes in Springfield and 150 violent crimes in unincorporated Sangamon County. Despite this, 85% of respondents believe that reducing local crime is a top priority in the area. There are slight differences between how safe residents of Springfield feel compared to residents from other parts of Sangamon County. 22.5% of Springfield residents report feeling unsafe walking alone at night in their neighborhood, while 13.5% of residents from other areas in Sangamon County feel the same.

# Growing downtown Springfield is important to all Sangamon County residents

The majority of all Sangamon County residents, including those living outside of Springfield, believe that growing downtown Springfield is important. The survey finds that 47.9% of Sangamon County residents believe that growing downtown Springfield is very important and 33.6% report that it is somewhat important. There are not significant differences between those respondents who live in Springfield and those who live in other areas in Sangamon County, with 83% of Springfield residents believing growing downtown is important compared to 80.4% of individuals who live in other parts of Sangamon County.

# At-risk population groups in Sangamon County

One of the more troubling findings in the 2013 survey is the percentage of individuals who report being unable to afford housing, food, or healthcare for themselves or their family members. One-in-five respondents report that at least once in the past 12 months, they were unable to afford food (21.7%) or healthcare (20.9%). While housing insecurity is a lesser problem, only 6.7% of respondents report being unable to afford housing, the number of individuals in the community who are struggling daily to provide basic needs for themselves or their family members is concerning.

We find that these insecurities disproportionally affect individuals with disability, individuals without a high school diploma, younger respondents, and African-American respondents. For example, 47.8% of African-American respondents report not having enough money in the past 12 months to afford food for themselves or their family, compared to 18.3% of White respondents. In addition, 56.9% of all respondents report that they feel not everyone in their community gets a "fair shake" or is treated equally. And as we try to better understand these at-risk groups in the region, we also find that slightly more than half of respondents (51.5%) think it is the entire community's responsibility to take care of the disadvantaged members of the Sangamon County community.

#### From the Director:

When we set out to measure the quality of life in Sangamon County, we knew that the task ahead of us was daunting. Sangamon County is a diverse public, rich in history, a blend of both rural and urban communities; at the same time, a region adapting in order to remain relevant in the current economic environment. The 2013 Sangamon County Citizen Survey is an attempt to capture a glimpse into the lives of Sangamon County residents. We were interested in finding out what residents enjoy about their community, what they would like to see improved, how they rate local leaders, and an assessment of the overall quality of life in the region.

The executive summary has highlighted several positive and negative indicators for the region. As you delve further into the report, you will find more in-depth analysis on each topical area. And while this report by itself provides useful insight for local leaders and community organizations, the goal of this project is not simply to prepare this single report. Rather our purpose is to make data available on the quality of life in Sangamon County for the next decade. Researchers from UIS will be continually updating the website and issuing future reports so that government, community, and civic leaders will be able to make data-driven decisions in an effort to better our community.

The 2013 Sangamon County Citizen Survey serves as the benchmark for comparison as we track changes in Sangamon County over the next ten years. In the meantime, enjoy what residents told us about their current lives, including their struggles and their successes, in Sangamon County.



# College Education

13% of respondents received a post-high school degree from a local college or university.

90% of respondents believe it is either very important (57%) or somewhat important (33.1%) for an individual to have a college degree while less than 3% report they do not believe it is important.

#### Pre-K Education

In 2012, there were more than 80 pre-Kindergarten programs serving three, four, and five-year olds in Sangamon County (including Head Start, Preschool for all, preschool programs, and childcare centers). Three-fourths of respondents believe Pre-Kindergarten education programs are very important for the local community (75.4%) with an additional 13.6% reporting that they are somewhat important.

3 in 4 survey respondents believe Pre-K education programs are very important for the local community.

Individuals with lower incomes (less than \$60,000 annually) are more likely than those earning \$60,000 or more annually to report that pre-K educational programs are very important. Over 80% of individuals earning less than \$60,000 believe these programs are very important, compared to, on average, 70% of those earning more than \$60,000.

A higher percent of African American respondents think pre-K programs are very important (91.5%) than White respondents (75.8%).



Overall, the respondents in Springfield, Chatham, and Rochester believe the biggest change needed (if any) in order to improve K-12 education in their area is increased funding to schools. One-fourth of Springfield respondents report that their local school district needs to increase funding to schools, as did one-fourth of Chatham respondents, 44.4% of Rochester respondents, and only 4.8% of Riverton respondents. Riverton respondents are more concerned over increasing the quality of their teachers (23.8%) as well as improving leadership and administration (19%).

# Evaluating local education leaders

The majority of Rochester and Chatham respondents are confident in their local school board to effectively address problems in their school district, unlike Riverton and Springfield. As seen in the table below, Springfield respondents have the lowest levels of confidence in their school board.

# Parent Evaluations

Of the individuals with a child enrolled in public school, 41% report the education their child is receiving is excellent, with another 39.6 % reporting the quality of their child's education is good. Less than 19% of public school respondents report the education their child is receiving is either fair (17.3%) or poor (1.4%).

Parents with children in private schools had more favorable ratings with 73.3% reporting the quality of education their child is receiving is excellent,

20% reporting it is good, 6.7% reporting it is fair, and none of the respondents rating it as poor. In addition, 94.1% of respondents with children attending public school report that when thinking about their child's safety at school, they believe that their child is either very safe (57.2%) or somewhat safe (36.9%) as did 100% of individuals with children in private schools with 75% reporting that their child is very safe, and 25% reporting their child is somewhat safe.

In order to evaluate the K-12 education questions, we include breakdowns from respondents in District #186 as well as Chatham Unit #5, Rochester Unit #3A, and Riverton Unit #14. No other school district had enough respondents to report on their district independently. In addition, 136 individuals reported having a child who either attended a local public or private school.

# School districts in Sangamon County

When examining the four districts (Ball Chatham, Riverton, Rochester, and Springfield) that there are enough responses to analyze, we find differences across average teacher salary rate, four-year graduate rates, percentage of students who are low income, and total enrollment. Springfield is a much larger school district (more than 3 times as large as the next largest school district), has a higher percentage of low income students, and has the lowest four-year graduation rate. Rochester and Ball Chatham school districts have the highest four year graduation rates and the lowest percentage of low income students. Average teacher salary, high school four-year graduation rates, and the percentage of students who are low income were provided by the Illinois State Board of Education. The four-year graduation rate is calculated by dividing the number of students who graduate in four years or less with a high school diploma by the number of students who form the adjusted cohort (starting cohort plus transfers into the cohort, minus students who transfer out of the cohort, emigrate, or die) for that graduating class.

All of the school districts received positive evaluations in terms of education quality and safety from parents with children enrolled in public schools. The education quality rating and safety rating were survey items asked of respondents who currently had children enrolled in the public school system in their district. The education quality rating scale ranges from 1-4, with 4 representing an "excellent education quality" and 1 indicating a "poor education quality." The safety rating scale ranges from 1 to 4, with 1 indicating that the parents do not feel like their child is safe at school and 4 indicating that the parents believes their child is very safe at school. Overall, Ball Chatham parents rate their schools most positively with a 3.6 education quality rating and a 3.57 safety rating. In addition, Ball Chatham reports the second highest four-year graduation rate with 92.3% of high school students graduating in four years. Rochester parents give their schools a 3.5 rating in the quality of education and 3.41 rating in school safety and they have the highest four-year graduation rate. Springfield parents give their schools the lowest education quality rating (3.11) but the second highest rating in school safety (3.56). Riverton parents give their school a 3.38 education quality rating and 3.56 school safety rating.


A higher percentage of survey respondents report litter as a big problem in Sangamon County (27.2%) than in their local community (16.6%), or on their own street (10.6%). A larger percentage of rural respondents report litter is a problem in their community (21.8%) than urban (17.8%) and suburban (14.3%) respondents. We find the same difference when respondents are asked about litter on their street. 15.8% of rural respondents report it is a big problem, compared to 13.4% of urban respondents and 5% of suburban respondents.

# Air and Water Quality

While just under one-third (31.4%) of survey respondents reported being very concerned about water quality, only one-fifth of respondents (20%) reported the same level of concern about air quality. Concern over water quality seems to weigh heaviest on those respondents who reported living in the rural areas of Sangamon County. Thirty-seven percent of these respondents rate their level of concern toward local water quality as very concerned as compared to 33.8% of urban respondents and 26.3% of suburban respondents.

# Conserving the environment

The majority of Sangamon County residents report that conserving the local environment is very important for the well-being of their community (69.3%) as well as the well-being of them personally (64.4%).

## Local agricultural issues

While 70.9% of survey respondents reported they think local agriculture plays a major role in the Sangamon County economy, only 11.3% reported they were very informed on local agricultural issues.

Two-thirds of survey respondents report recycling at their home.

# 2 in 3 survey respondents reported that knowing a product is locally grown makes them "more likely" to purchase that product.


# Do you have access or need access to a community garden?

78.9% of survey respondents report not having access to a community garden. Of these individuals, 61.2% report not needing access and 38.8% report needing access. This means that one-third of all survey respondents report currently not having and yet needing access (30.6%) to a community garden.

The need for access is most prevalent among individuals with lower incomes. 68.4% of respondents making less than \$15,000 a year report not having access to a community garden and needing one.

This is 28 percentage points higher

than the next income category (\$30,001 to \$45,000 a year) reporting the same need.



# Local Waste Management

There are mixed results among survey respondents' attitudes towards recent proposals to consolidate local waste management services, as 41.3% report they oppose the idea, 33.7% support it, and 19.3% have no opinion or are neutral.

By location in Sangamon County, Chatham and Springfield residents are the most negative, as 45% of Chatham and 40.9% of Springfield respondents opposing it. Rochester respondents are mostly neutral (64.3%), as 21.4% oppose and 14.3% support it.

Of the 33.5% of respondents who do not currently recycle, the top reason given for not recycling was lack of interest.

# Right Track

- 59.5% of respondents report things are generally on the right track.
- 67.7% of individuals between the ages of 25 and 34 report things are on the right track. This was six percentage points higher than any other age group.
- A larger percentage of individuals with higher levels of education and income report things are on the right track in Sangamon County. In fact, more than three-fourths of individuals making between \$60,001 and \$75,000 a year report that they think things are on the right track.
- Rural and suburban respondents were more likely to report things are on the right track (with 65% and 63.3%, respectively), than urban respondents (50%).

# Wrong Direction

- 30.6% of respondents report things are going in the wrong direction in Sangamon County, Illinois.
- African-Americans report things are going in the wrong direction at a higher rate (37.2%) than either Whites (31.7%) or Hispanics (30%).
- More than half (55.6%) of individuals with less than a high school diploma report things in Sangamon County are going in the wrong direction, compared to 23.4% of individuals with a college degree and 19.6% of individuals with an advance degree.
- 57% of individuals earning less than \$15,000 a year report they believe things are going in the wrong direction.



Over the past three years, both Springfield and unincorporated Sangamon County have seen a decrease in violent crimes. In 2010, there were reported 1,452 violent crimes in Springfield and 170 in unincorporated Sangamon County. In 2011, there were 1,258 violent crimes in Springfield (no data available on the unincorporated area). Most recently in 2012, there were 1,138 violent crimes in Springfield and 150 violent crimes in unincorporated Sangamon County.

# 18.2% feel unsafe walking alone at night

Do you feel safe or unsafe walking alone at night in your neighborhood?

This sentiment is more common among respondents who were female (22.7%), between the ages of 18 and 24 (32.4%), African American (19.6%), earning less than \$15,000 a year (37.8%), and living in an urban environment (25.5%).

# 16.4% report no police and law enforcement presence

How often, if at all, do you see police or other types of law enforcement patrolling your neighborhood or street?

Only 16.4% of respondents report seeing police not often at all. The majority of respondents report that they see police or other types of law enforcement patrolling their neighborhood either very often (30.6%) or somewhat often (24.1%).

85% believe reducing local crime is a high priority in Sangamon County.

#### 10.9% feel less safe in their own homes

Compared to a year ago, do you feel less safe, safer, or about the same level of safety in your own home?

15.2% of African-Americans feel less safe now than a year ago compared to 10.6% of white respondents. Of the respondents who reported feeling less safe in their homes, 57.1% report that they would move away from their current neighborhoods if they could.

# 11.5% feel unsafe traveling on local streets

How safe or unsafe do you feel it is to travel on local roads and highways?

Less than 12% of respondents reported feeling either unsafe (9%) or very unsafe (2.5%) when traveling on local roads and highways. In 2011 there were 4,869 vehicular accidents in Sangamon County, 415 fewer than in 2010.



How are your personal financial conditions and local area business conditions today, compared to a year ago?





# Sangamon County's Unemployed or Underemployed Citizens

While only 3% of respondents report currently being unemployed and seeking employment (the actual unemployment rate in Sangamon County according to U.S. Bureau of Labor Statistics is 7.6%), 21.2% of the employed respondents consider themselves to be underemployed. The majority of both unemployed and underemployed Sangamon County residents believe that employment training programs are important for the area. One-fifth of underemployed and 28.5% of unemployed respondents report participating in such programs in the past.

#### Local area business conditions



Only 13.1% of Sangamon County residents believe that current local business conditions in the county are better off than they were a year ago. The majority of respondents report local business conditions are about the same (56%) and 28.6% report that local area business conditions are worse off today than they were a year ago.

Sangamon County experienced less than a 1% job growth from 2011 to 2012.

- 83.7% of respondents believe attracting new businesses and jobs to Sangamon County are a high priority for the area.


#### Tax Priorities

Sangamon County residents give mixed responses when asked whether "not allowing new tax increases" or "decreasing property taxes" were a high priority, medium priority, low priority, or not a priority at all. 37.6% of respondents report not allowing any tax increases is a high priority, 30.6% believe it is a medium priority, 21.2% said it is a low priority, and 9% reported it is not a priority at all. In comparison, 35.7% of respondents believe that decreasing property taxes is a high priority, 29.3% report it is a medium priority, 23.3% say it is a low priority, and 10% report it is not a priority at all.

Sangamon County residents were asked a series of different questions gauging their support for increases in either property taxes, local sales taxes, or whether they would not support any tax increases in order to fund

- a) alternative transportation,
- b) local public school,
- c) road and transportation improvements.

For all three categories, a higher percentage of individuals report they would not support any tax increases than support any form of increase. The tax increase receiving the most support deals with supporting local public schools. 37.8% of respondents report they would support an increase in local sales taxes to support local public schools.

# Traveling in/out of Area

Residents and visitors of Sangamon County have several options when it comes to traveling in and out of the area. In 2012, the Abraham Lincoln Capital Airport handled 138,135 passengers and 192,216 passengers went through the Springfield Amtrak station. When survey respondents were asked about their traveling out of the town in the past year, a higher percent report using Amtrak than the Abraham Lincoln Capital Airport and Intercity buses combined.







#### Health Status .....

When asked about their health in the past 30 days, 53.3% report there was at least one day in which their physical health was not good, 38.9% report there had been at least one day in which they had been kept from usual activities due to health, and 18.3% report at least one day in which their mental health was not good. When comparing these rates to the most recent statewide data (2011 Behavioral Risk Factor Surveillance Survey) we find that while a higher percentage of Sangamon County residents report that their physical health was not good on at least one day than statewide respondents, a lower percentage report that their mental health was not good or they were kept from usual activities due to health on at least one day.

In addition, 19.9% of respondents say they have not engaged in any physical leisure time activity in the past 30 days compared to 25% of Illinois respondents. 91.5% of Sangamon County residents think physical activity is very important to your general health.



# Sangamon County's Uninsured Population

11.3% of respondents in the 2013 Sangamon County Citizen survey report not having health care coverage (including health insurance, HMOs, government plans, or Medicare). This is slightly lower than the statewide estimate provided by the most recent American Community Survey, which reports the statewide uninsured rate at 13.1%. One in four individuals under the age of 34 report not having health insurance as do 37.8% of individuals making less than \$15,000 a year, and 33.3% of individuals without a high school diploma. African Americans also report a higher uninsured rate (19.1%) than White respondents (9.2%).



A higher percentage of African American respondents give their local library or local park a poor rating. 12.8% of African American respondents rate their local park as poor, compared to 5.5% of White respondents. 21.7% of African American respondents also rate their local library as poor, which is a 15 percentage point increase over the percent of White respondents who rate their local library as poor.

Rural respondents are the most negative in their evaluations of local parks and libraries with 8.9% rating the quality of their local library as poor, compared to 5.7% of suburban respondents and 5.7% of urban respondents. In addition, 11.8% of rural respondents rate the quality of their local park as poor, compared to 10.1% of urban respondents and 4.4% of suburban respondents.



# Strong or Weak Leaders?

# 52.4% of Sangamon County residents feel Sangamon County has weak leaders.

This evaluation was most common among male respondents (57.3%), individuals between the ages of 45 and 54 (59.3%), African-American respondents (61.4%), individuals making less than \$15,000 a year (75.0%), and individuals without a high school diploma (88.9%). Additionally, large differences in sentiment were reported by those who identify as LGBTQ and those who report having a disability. 70.6% of those who identify as LGBTQ believe that Sangamon County has weak leaders, which is almost 20 percentage points higher (52.1%) than those who do not identify as LGBTQ. Of those who report having a disability, 69.9% believe Sangamon County leaders are weak, also a 20 percentage point increase (49.6%) over those without a disability.

# Confidence in Local Leaders?

57.7% of Sangamon County residents are confident that local leaders can effectively address local problems.

In general, women (63.5%) are more confident in local leaders than men (52.1%). Individuals between the ages of 45 and 54 are the least confident (44.3%) while those aged 18-24 are the most confident (66.7%).

Education level also made a large difference in confidence as those with less than a high school degree report being less confident. 32.1% of individuals without a high school diploma report being confident in local leaders, which is almost 30 percentage points lower than the percentage of individuals with an advanced degree (61.7%) who reported they are confident in local leaders.

Confidence levels did not differ based on whether respondents voted in the most recent election.


# Confidence in Elected Leaders?

51.7% of Sangamon County residents are confident that local elected leaders can effectively address local problems. Of the respondents who voted in the last election, 54.3% are confident in local elected leaders.

Specifically, again, women are more confident (58.3%) than men (44.9%) and those between the ages of 18 and 24 are the most confident (70.0%) while those between the ages of 45 and 54 are the least confident (43.2%).


Additionally, income and education levels matter with those making less than \$15,000 a year being the least confident (22.2%) which is 50 percentage points below those making \$75,001 to \$100,000 a year (73.2%). Individuals without a high school diploma have less confidence (33.3%) than those with a four-year college degree (60.4%).

# Would you say most people can be trusted?




**49.3**% believe you cannot be too careful when dealing with people. **35.3**% of women and **40**% of men believe most people can be trusted. **60.9**% of African-Americans believe you can't be too careful when dealing with people.

# Would you say people try to be helpful?



**56%** believe that most of the time people try to be helpful. **72%** of those making \$60,001 to \$75,000; and **25.4%** of those making \$15,001 to \$30,000 believe people try be helpful. **40%** of those with a disability believe people only look out for themselves.

Since 1972, the General Social Survey (GSS) has been monitoring societal change in America. Conducted by NORC, at the University of Chicago, the survey is largely regarded as the most comprehensive data on contemporary American society. The 2013 Sangamon County Citizen survey contained several questions included in the GSS in order to examine how Sangamon County compares to the national average. Below, we present two comparisons: "Would you say most people can be trusted" and "Would you say people try to be helpful." The graphs include longitudinal data from NORC, but also include our data from Sangamon County residents. As you can see, on both trust and helpful, Sangamon County residents have higher evaluations than the most recent national average (2012).

# Where do Sangamon County residents get local news

According to the Citizen Survey, Sangamon County residents rely on two main sources for local news: 39% cite television as their main source, while nearly as many, 37%, cite newspapers. 10% use radio as their main source for local news, while only 7% use the Internet as their main source for local news. A very small percent (4%) rely on word of mouth for local news.

When respondents were asked whether they watch local television news, listen to local news on the radio, read a local newspaper, or read local news online on a normal day, we find interesting age group differences. The youngest age group (18-25 year olds) reports the lowest levels of news consumption across all mediums except television. 82.4% of 18-24 year olds report watching local television news. 25-44 year olds report the highest levels of news consumption, especially through local radio and the Internet. Approximately 70% of these individuals report getting local news through the radio or the Internet on a normal day. Older respondents (ages 55 and older) are most reliant on the local newspaper with 72% reporting that they read a local newspaper on a normal day.



# Comparing Sangamon County to statewide results

When we compare Sangamon County citizens to a statewide survey of Illinois residents, we find differences in their levels of community service, participation in civic groups, and religious attendance.<sup>34</sup> According to a 2009 statewide survey conducted by the UIS Survey Research Office, 63.2% of Illinois residents are involved in community volunteer activities, 31.6% participate in a school, neighborhood, or civic groups in the past year, and 56.8% are a member of a church, synagogue, temple, or mosque. In the 2013 survey, we find that 45.2% of Sangamon County residents report being involved in community volunteer activities, 21.4% participate in school, neighborhood, or civic groups, and 63.1% are a member of a church, synagogue, temple, or mosque.
