Our Council on Professional Education is made up of faculty, staff, students, and practitioners from the community, all of whom have input into the needs of local schools and new teachers. Almost all of our courses include practicing teachers and administrators from the area, providing candidates with grounded "real world" teaching perspectives. All professional course work is developed around the 2013 Illinois Teaching Standards and the appropriate Specialty Professional Area (SPA) standards. Course work includes instruction on the Common Core State Standards, teaching students with exceptionalities, and working with students who represent a wide range of socioeconomic circumstances, cultures, languages, races, family structures, and geographic locations. Teacher candidates at UIS complete multiple pre clinical field experiences in schools that total a minimum of 120 clock hours before entering their student teaching experiences, so they have a wide range of experience with students and teachers. The program requires that at least one pre-clinical (before student teaching) experience be in a building that is considered diverse ethnically or socioeconomically per the Illinois school report card.
