### POLICY

- 1.) Courses for units within the College of Public Affairs and Education will have enrollment capped as follows unless an exception has been approved:

All Graduate Courses	20
All Online Courses	20
Undergraduate Upper Division On Ground	30
Undergraduate Lower Division On Ground	35
Capstone or other specialty courses	15 or 20

- 2.) Exceptions to the course enrollment cap will be reviewed by the College Cabinet as needed and proposed exceptions must be approved by the College Executive Committee and the College Dean.
