#### From the east - using US 36/72:

At intersection with I-55, choose I-55 South, following it to Stevenson Drive exit (#94). Turn right (west) at top of exit ramp, proceed through 2 traffic signals; at 3rd signal, turn left (south) onto West Lake Shore Drive and proceed to parking lots C or D.
