Application Process

For nearly 50 years, the Graduate Public Service Internship Program has been ranked one of Illinois' premier governmental internship programs. GPSI provides interns the opportunity to simultaneously experience a public sector internship while earning a master's degree from the University of Illinois Springfield.

What does a GPSI intern do?

As a GPSI intern, you will have the opportunity for an internship experience that is compatible with your academic background, graduate program, and skills. Historically, GPSI interns have completed challenging internships in the areas of economic forecasting, grant writing, research, writing press releases, preparing television public service announcements, marketing, statewide conference management, laboratory analysis, environmental sampling, research on endangered species, website development, computer programming, database development and management, statewide audits, and public health research.

FAOs

When does the internship begin?

Annually on August 16 for Fall applicants, and January 16 or February 1 for Spring applicants.

How are interns selected?

GPSI is a competitive internship program. Students are considered based on their academic backgrounds and previous work experience and then selected following and interview.

Is there a minimum GPA to be eligible?

Cumulative undergraduate GPA of 2.5 is required, and applications with graduate coursework already completed must have a 3.0 GPA to be considered.

Can online students apply for a GPSI position?

Yes. GPSI places online students living in and around Springfield and Chicago.

Can international students apply for a GPSI position?

Yes. However, F-1 visa status is required to be eligible for the program.

Intern Benefits

Monthly Stipend

During the fall and spring terms your monthly stipend is \$1,200 for 20 hours per week of work. During the summer term, you work 40 hours per week and the monthly stipend doubles to \$2,400.
